As we have transferred over to more efficient systems, there is a period of change for communication to ensure that we are using the systems to benefit all parties. We provide as much notice as possible but some events are out of our control with a quick turnaround. SQuid has been a difficult platform to manage—we have closed our contract and will receive refunds in 90 days (we are working on reducing this amount of time) - once the refunds have been received, we will issue them onto School Money accounts.
